# Facts and Stats Grade "A" for March

According to Idaho Code 39-5701, the Idaho Department of Health and Welfare must inspect each business that sells tobacco to ensure that it does not sell tobacco to minors. In **March 2017**:

- 283 Vendors were inspected. \*
- 18 Vendors sold to the inspecting minor.
- The compliance rate for the month was 93.64%

\*Inspections where purchase attempts were made.


# If it's GREEN, STILL Say NO to the Teen

Under Idaho law it's illegal to sell tobacco to minors. This means anything that contains tobacco including cigarettes, tobacco, tobacco papers, snuff, cigars, electronic cigarettes, pipes, hookah and smokeless tobacco. If you sell to a minor, you could be fined \$100 and lose your job. Always ask for a photo ID and LOOK FOR THE GREEN BOX TO THE RIGHT OF THE TOP PHOTO.
